# BSA 2025 FAQs

Question:

Q: Do we need to **submit a video** along with technical presentation material?

Q: What are the **materials** needed to be submitted **before early-bird deadline**?

Q: **Can we apply if we don't have Building Surveyor (BS)** in our company?

Answer:

A: **Video is only required for “Project Outside HK Category”** for jury panel’s assessment purpose. Finalists shall submit **1-min video submission for the Most Popular Award**

A: **Simply submit the nomination form with fee by early bird deadline (30 Jun)**

Technical proposal shall be submitted by 25 Jul

A: **As long as a BS is involved your project, you are eligible to apply.**

\*The BS involved shall participate in the whole assessment process

\*The BS involved shall have a leading role/substantial involvement in the project

# BSA 2025 FAQs

Question:

Q: Can a **rolling program apply** for BSA 2025?

Answer:

**We accept Phrase Completion** which is completed between 1 April 2020 and 11 July 2025.

Q: Can we **apply for more than 1 category** for same project?

A: **Yes. But** you need to **highlights different achievements** referring to the category's definition and assessment criteria.

A nomination fee will be collected for nominated project submission for each category

# BSA 2025 FAQs

Question:

Q: What information is expected to be submitted for **item 2 (project team details)** ?

Answer:

A: 1) **Organisation Chart of the Project** (such as Applicant, Consultants, Contractors, other team members, etc);  
2) **Building Surveyor(s)** and their Company Name, and their roles in the project

Q: Do you accept **joint submission**?

A: Unless you are joint-venture company, **we only accept 1 company** to be the representative **for the nomination.**

Question:

Q: How can BS to be promoted if the applicant isn't a building surveying firm?

Q: **What are the role and obligations of "Client"** for nominating the applicant to participate BSA 2025?

Answer:

A: 1) **The full project team details** of the awarded project will be **published in the event booklet**.

2) **Building surveying firm and the BS names** of the awardee(s) will be **listed in the local newspaper supplement**.

A: As supporter, client should **agree the disclosure of relevant information** and **allow site access** for participating the award
